<u>Old Business</u> – Council entertained nominations for election of officers among councilmen. Motion made by Weber, second by Cratsenburg to nominate Zack Karnaz for the position of President. Karnaz accepted the nomination. Karnaz asked if there were any other nominations. Motion by Weber, Cratsenburg declined the nomination. No other nominations. Roll call vote: Cratsenburg, yes; Weber, yes; Hart, yes; Shafer, yes. All ayes, motion passed.

Motion made by Weber, second by Karnaz to nominate Shaffer for Vice President. Shafer accepts the nomination. Roll Call Vote: Cratsenburg, yes; Weber, yes; Hart, yes; Shafer, yes. All ayes, motion passed.

On the issue of 4 year vs. 2 year term for a tied vote in the general election combining Jackson and Lenawee County votes, Weber flipped a coin for the 4-year term assigning heads to Karnaz and tails to Shafer. Coin flipped to heads. Karnaz will serve a 4-year term (Nov. 2024) and Shafer will serve a 2-year term (Nov. 2022).
